1 THE COURT: All right, we'll call up 12 T 2444,
2 and 15 T 1778, People versus David Wilkenson.

3 All right. The court has had opportunity to look
4 at the motion to dismiss, the People's reply, and the
5 defendant -- the People's response, and the defendant's
6 reply to the defendant's -- the plaintiff's response.

7 So, I've had a chance to look at those things, and
8 I guess if you want to make any further record or argument
9 or evidence at this point in time, Mr. Wilkenson, you're
10 free to do so.

11 Is there anything else you wish to put on with
12 regard to evidence or argument?

13 MR. WILKENSON: Well, I think I put it all in the
14 reply, Your Honor. I mean, my Constitutional issues, the
15 Statutory issues, the jurisdictional issues, and the case
16 law.

17 THE COURT: What exactly are you asking me to
18 find?

19 MR. WILKENSON: I think that because Mr. Weidinger
20 said this is not really a good forum to do that, which was
21 my argument for the un-Constitutionality, I mean, to be able
22 to in this state to have an agency just come in and pull
23 somebody's license, as I stated in there, you know, driver's
24 licenses are public safety issue legitimate with the state.
25 If you don't drive safely, if you're a drunk driver, if you

1 do whatever, then the state has an obligation to the
2 people's safety concern that they restrict your ability to
3 drive depending upon how you're driving.

4 This doesn't involve a driving record or anything.
5 It just involves those guys want to do what they say. And
6 so that's the un-Constitutional part, and how they go about
7 doing it.

8 And the law allows them to do that. That's
